later in 1994. This will be a substantial boost to the Australian extraterritorial law on child sexual exploitation.

## REPORT ON OPPOSITION'S ABOUT-FACE ON CHILDREN'S RIGHTS

The attempt by the Federal Opposition to prevent the inclusion of the UN Convention on the Rights of the Child(CRoC) in the Human Rights and Equal Opportunity Commission Act 1986 has failed by two votes.

The vote along party lines was predictable once the Democrats and the WA Greens combined in the Senate to defeat the Motion of Disallowance initiated by Shadow Attorney-General Daryl Williams. In the lower house the motion was also defeated and Opposition House of Representatives member Steele Hall crossed the floor to support the government, claiming of his colleagues: "It is a great disappointment that so many cannot or will not understand this Declaration."

The formal step of listing CRoC as a human rights instrument over which the HREOC has jurisdiction has now been successfully completed.
