BUILDING SMALL DEMOCRACIES: the implications of UNCROC for respecting children's civil rights within the family. Children's Rights Office, UK 1995. £5.00 plus p&p.

This handbook is aimed at parents and all those working with and for families and children in response to the IYF slogan "building the smallest democracy at the heart of the family." The status of children in families is considered in relation to parental responsibilities as expressed in the Convention, children's "evolving capacities" to selfdetermination and children's civil rights, (ie. to identity, integrity, freedom of expression, thought etc, privacy and information).

The issues arising from each right is discussed, UK law is examined, reforms proposed and developments in the laws of other countries (mainly Europe) are reported.

CHILD HEALTH RIGHTS: Implementing UNCROC within a Health Service - a practitioner's guide. British Association for Community Child Health, UK 1995 £1.50. Aimed at those working in everyday health services and allied professions, this guide translates the Convention into everyday examples of the importance of the Convention to health and health care. It aims to promote good practice in relation to service delivery, rights to information, participation, physical integrity and privacy.


When can I? Children, young people and the law in South Australia. Children's Interests Bureau, SA 1995. \$4.50 plus p&p.
