## Update - Children's Commissioners

The Australian organisation 'Kids First Foundation' has added its voice to the many Australian non-government organisations calling for the establishment of a Commissioner for Children within a Federal Office for Children. The focus would be on child protection and co-ordination of a national approach to child abuse prevention and treatment. The Foundation's Chairwoman, Beryce Wilson, highlighted the major problem of the lack of uniform child-protection legislation and the need for uniform notification laws, approaches to prosecution and treatment services.

Which reminds us! What *is* the Government doing or what does it intend to do, regarding implementation of related recommendations in the Australian Law Reform Commission / Human Rights and Equal Opportunities Commission report 'Seen and Heard - Priority for Children in the Legal Process' and the Joint Standing Committee on Treaties Report on the UN Convention on the Rights of the Child. The former advocated an office for Children with the Department of Prime Minister and Cabinet, the latter an Office for Children as an independent statutory authority attached to the Prime Minister's Portfolio.

## Victorian Health Initiative

The Victorian Government recently announced the establishment of a Ministerial Advisory Committee on Gay and Lesbian Health in order to properly identify health needs that require special focus and find effective ways to address them. Minister for Health, The Honourable John Thwaites MP has said the Committee would be asked to develop an action plan within a 12 month time frame. Two major issues will be investigated:

- The range of health risks relating to lifestyle behaviours and social pressures.
- The barriers, and often discrimination, faced by gay men and lesbians in accessing and using health services.

The Committee will comprise 12 to 15 people encompassing health professionals, academics/researchers and community nominations. One of the first tasks of the Committee will be to establish a detailed community consultation process.
