ESSENDON COMMUNITY LEGAL CENTRE GOES TO THE HIGH COURT

In June 1993 the Essendon CLC acting for a woman who was sexually abused as a child was given leave by the High Court to appeal against the AAT refusal of her crimes compensation claim on the grounds that too much time had passed.

The abuse occurred between 1974-1980 and a crimes compensation claim was made to the Crimes Compensation Tribunal in 1990. This claim was turned down and she appealed to the AAT. This was also unsuccessful. Although claims for crimes compensation normally have to be lodged within a year of the injury, the legal centre argued that where a person is a victim of incest or sexual assault they often cannot deal with it until adulthood.

The legal centre referred to recent overseas court decisions that normal time limits of compensation claims should not apply to injury in childhood. The centre believes that victims of sexual assault who were abused in childhood do have special circumstances.

The appeal to the High Court, Canberra has been listed for 9 September 1993.
