A book dealing with the problems of people who are unable to pay PERIN fines. These people could eventually be gaoled if the fine is not paid. The book instructs how to bring cases that have reached Warrant stage, but not yet been executed, back to the Magistrates Court. Preferable outcomes are available, including discharge (if the issuing agency fails to appear) and communitybased orders.

CLINICAL LEGAL EDUCTION AT MURDOCH

WA's first Clinical Legal Education Program commenced at Murdoch University in March 1997. Jointly funded by Murdoch University and the Commonwealth Government, the Clinic will initially run as a three-year pilot project.

The Clinic has been developed by Murdoch University in partnership with the Kwinana-Rockingham Community Legal Centre. Students will be placed at the Southern Communities Advocacy, Legal and Education Service (SCALES), a new full- time community legal centre being established to replace the Kwinana-Rockingham CLC, which due to lack of funding, operated as an evening legal advice bureau only.

SCALES will operate from **pre**mises in Rockingham, kindly donated by the Rockingham City Council, in one of the fastest growing metropolitan areas in Australia, with a high level of unmet legal need.

The Clinic will have a mentoring relationship with Monash University/

Springvale Legal Service, on which the Murdoch program will be modelled. The unit, which will be formally known as Clinical Legal Education, will be offered to final year law students. There will be three intakes of students every year, with each intake having approximately 25 students. The students will have two weeks of introductory seminars, followed by placement at SCALES for a period of 16 weeks.

The Clinic will focus on an appreciation of the dynamics of law as social practice, professional ethics, the interaction of law with other disciplines, necessary legal skills and personal student development.

The Director of the Clinic is Michael Hovane, a Perth lawyer, formerly at Consumer Credit Legal Service.

The program represents an exciting and important pedagogical development in the undergraduate law course that has the potential to impact on graduates and the legal profession in WA in a variety of ways.
