# INTERNATIONAL DISABILITY LAW AND POLICY PROJECT

The International Disability Law and Policy Project (the Project) is currently seeking law student volunteers to conduct research on the world's existing disability laws, weigh the pros and cons of various policy models, and assist disability activists worldwide in formulating and advocating for legislative and judicial solutions appropriate for their local needs. The Project is affiliated with Disabled Peoples International (DPI), an international nongovernmental organisation with members in some 120 countries that works closely with inter-governmental bodies such as the United Nations and the International Labor Organisation in promoting the human rights of people with disabilities. The Project represents a unique opportunity for students interested in comparative, human rights, disability, or public interest law to collaborate with legal professionals abroad and gain practical experience with the laws of many nations. Not an academic exercise, the Project provides volunteers with the chance to work for an international client base of disabled people trying to make concrete improvements in the quality of their lives. Student hours are flexible, and the Proiect can accommodate volunteers who wish to make small or substantial time commitments. All are welcome to contribute, but students with a knowledge of foreign legal systems or languages are especially encouraged to apply.

# **NATIONAL SORRY DAY** 26 MAY 1998

A Sorry Day is being held exactly a year after the tabling in Federal Parliament of Bringing Them Home, the report of the National Inquiry into the removal of Aboriginal and Torres Strait Islander children from their families. The report reveals the extent of forced removal, which went on for 150 years into the early 1970s; its consequences in terms of broken families, shattered physical and mental health, loss of language, culture and connection to traditional land and community, and the enormous distress of many of its victims today.

The report recommended that a Sorry Day be held — a day when all

Australians can express their sorrow for the whole tragic episode in Australia's history and celebrate the beginning of a new understanding. Many of the 'stolen generations' told the Inquiry that this would be a necessary part of their healing. Many non-Indigenous Australians, having learnt the history of forced removal, wish to apologise for the past practice and its contemporary consequences on the health and incarceration rates of Indigenous peoples.

Sorry Day invites every Australian and every community to shape a ceremony which, by the frankness of its acknowledgment of past wrongs towards the 'stolen generations', and by the sincerity of its commitment to overcome racism, unites the community. Sorry Day will be an important start to honouring the survival, strength and resilience of the stolen generations.
