The *Sydney Morning Herald* reported a story on 22.09.00 from Le Lavandou, France where apparently the mayor of a village on the French Riviera whose cemetery has run out space had issued a decree telling people not to die.

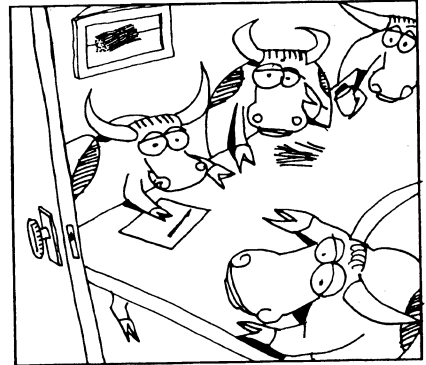
"It is forbidden for any person not in possession of a family vault to die on the village's territory," the order stated.

Gil Bernardi said the decision had been taken after a court in Nice blocked plans to build a new cemetery after a complaint lodged by the local Green Party.

"Article 2013 of the local authorities' code obliges the mayor to provide for the rapid burial of bodies. I have a duty, and I cannot respect it. It is absolutely impossible," he said.

"The Greens want us to put the new cemetery in a remote quarry. We can't get rid of our dead in a dump."
