Bulletin of Words and Phrases

The Bulletin of Words & Phrases (BWP) is an accumulating compilation of words & phrases judicially considered in reported and unreported decisions of the High Court of Australia, Federal Court and all Australian Supreme Courts.

The compilation is stated to be current to August 1999 and is a free service.

The BWP gives either an expanded definition of the particular word used in its context or simply indicates the context.

The stated objects of BWP are to extract pithy judicial quotations on the meanings of words and phrases in their context and pointing to the relevant unreported and reported cases for the researcher to study.

BWP references are individually selected — not simply harvested by over-inclusive computer searching techniques — so as to provide references of some practical value to researchers (a similar concept being used in looksmart.com.au advertising to differentiate itself from other search engines).

This site may be a useful in the early stages of your research. I will be particularly interested to see how often the site is updated, given that the content is current to August 1999.

GST and the net


