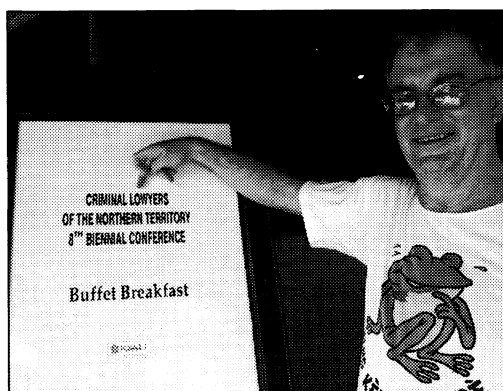


## Want to be a millionaire?

## Down on their luck

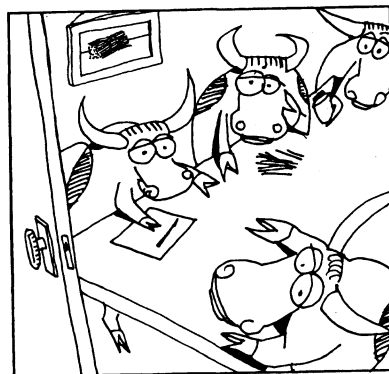
Despite the small size of their firm (three lawyers and an articled clerk) Darwin firm Halfpennys managed to enter four teams into a recent volley ball competition between firms.
