London January 2001: A man created legal history as the first defendant to appear in court entirely naked.

Judge George Bathurst-Norman allowed Vincent Bethell, 28, to appear in the courtroom 'in the duff' but insisted he remain seated in the waist high dock.

According to the Sydney Morning Herald (12 January 2001) the defendant was excused having to stand when the judge entered the room "to spare the blushes of female jurors."

"For the first few days of the week-long hearing the judge ordered the court to be cleared everytime Mr Bethell was led in and out of the dock. He later dispensed with this at the request of Mr Bethell's lawyers but advised female jurors to avert their gaze when Mr Bethell was walking to and from the dock."

Mr Bethell was in court charged with causing a public nuisance. He had been arrested six times — five in London and once in Bristol.

He was cleared of his charges.


