

Reinventing cataloguing

Reinventing cataloguing, the 11th National Cataloguing conference will be addressed by a range of speakers whose papers will explore the challenging environment cataloguers and all information professionals now find themselves in.

Keynote speaker Barbara Tillet from the Library of Congress will address the conference on *Cataloguing rules and conceptual models for the electronic environment*. Keynote speaker for the second day, Julia Trainor, National Library of Australia, will discuss the impact of *World 1* on cataloguing in Australia.

They will be followed by a range of leading Australian speakers, including Toby Burrows who will present a paper titled *Bibliographic*

services in the client-centred academic library. Patrick Condon and Jan Gaebler will each present *Scenarios for cataloguing*. Lesley Bezeal, Jenny Todd and Philip Keane will each present papers under the theme *Challenges of new technology*. The theme *Apply the rules, or invent new ones?* will examine the adequacy of current formats with papers presented by Bob Pymm and Paul Hodgson. *Reinventing the tools of the trade* will be an opportunity to examine the way cataloguers work with papers by Clara Ichlov and Faye Pattinson, Eddie Turker, Margaret Hyland and Adrienne Kebbell. *The new cataloguing department* will be examined by Kerrie Talmacs and Reg Mu Sung, Helen Hoffmann and Bernadette Law.

The conference will be preceded by the Australian committee on cataloguing seminar titled: *Rule revisions: Who needs them?* and will include *Main entry* — a debate

between Giles Martin and Pam Dunlop.

The social program will include a cocktail reception in the Mitchell Galleries, State Library of NSW where participants will be able to view *Out of line: 25 years of women's posters* and *The work of art: Australian women writers & artists*. The conference dinner with the theme *Reinventing the tradition*, is on Thursday evening so dust off your song books, tune up your voices and be prepared for some fun!

The conference will be held from 19–20 October, with the ACOG pre-conference on Wednesday 18 October. The venue is the Sheraton on the Park, Elizabeth Street, Sydney. Reengineering technical services

Cataloguers and Acquisitions sections joint event

The ALIA Acquisitions Section, NSW and the ALIA Cataloguing Section, NSW are pleased to announce that Arnold Hirshon will be their guest speaker on Tuesday, 26 September.

Mr Hirshon has been the University Librarian (Director of Libraries) at Wright State University, Ohio since 1990. He has had many years of experience in university libraries and has reengineered both reference and technical services. He will be in Australia in September to attend the RAISS conference in Adelaide, where he will be a keynote speaker.

Wright State University was one of the first libraries in Ohio to implement the state of the art OhioLINK library system. Under Mr Hirshon's leadership, Wright State also created a local common interface to the OhioLINK databases, to a local CD-ROM network, and Internet resources.

Some other efforts undertaken during his administration included radically changing the delivery of reference and research services, outsourcing cataloguing, and intro-

ducing team management to the collection and outreach operations.

Arnold Hirshon has a substantial publication record and is currently working on a book entitled *Outsourcing library technical services*, due for publication in 1996. He is a frequent lecturer in the United States on the challenges presented by electronic information and on organizational change.

Mr Hirshon will address the sections on the reengineering of libraries, and technical services in particular. He will cover the general principles and methodologies of reengineering and will explore issues such as outsourcing, team-based management and collaborative programming.

Mr Hirshon will also present an overview of current US developments in the area of technical services management structures, including the combining of technical services functions with other library functions, the flattening of the organisational hierarchy and the future of technical services.
