CUSTOMS TARIFF (WORLD TRADE ORGANIZATION AMENDMENTS) BILL 1994

General Outline

The purpose of this Bill, is to amend the Customs Tariff Act 1987 to give effect to Australia's tariff binding commitments arising from the General Agreement of Trade and Tariffs Uruguay Round outcomes.

Financial Statement

Australia has made significant reductions in tariff rates since 1988 and by 1 July 1996 most of the tariff rates will be 5%.

The changes to cheese and unmanufactured tobacco have the potential to be most damaging. Cheese is currently subject to quantitative quota restrictions. For a number of years imports of cheese have not exceeded quota entitlements and therefore it appears there will be no loss of revenue from the reductions in tariff levels for cheese.

Unmanufactured tobacco is currently subject to alternate rate duty. The changes contained in this Bill seek to remove the alternate if lower tariff rate. The result of the changes will be to marginally increase the import duty collected on unmanufactured tobacco.

Other changes will have no significant effect on overall tariff revenue receipts from imported goods.

Covers

Australia made a commitment to reduce tariff rates for certain goods under the terms of the Uruguay Round Agreement. Most of these reductions are already in place because of the Government tariff reduction programme commenced in 1988. This Bill introduces the small number of changes necessary to comply with our undertakings under the new Agreement.

The changes to cheese and tobacco are most significant as they come into effect immediately this Bill becomes effective. Other products affected include such diverse items as foodstuffs, very low alcohol beer, diagnostic and laboratory reagents, certain replacements components of motor vehicles, power line filters and electro-medical equipment and apparatus.
