OUTLINE

Honey (Export Inspection Charge) Collection Bill 1984

This Bill is associated with the Honey (Export Inspection Charge) Bill 1984 which will be introduced simultaneously. It provides for the collection of charges proposed in that Bill.

The Bill establishes the date on which payment of the charge is due. It provides for the recovery of the charge (including penalty for non-payment), the remission of penalty, in whole or in part, where appropriate, and access to premises by authorized persons (including penalty for obstructing or hindering such persons). The functions of authorized persons are laid down.

(2)	Establishes procedures whereby an authorized person may apply to a Justice of the Peace for a warrant to enter premises
(3)	Establishes circumstances in which a Justice of the Peace may issue a warrant
(4)	The date after which a warrant ceases to have effect shall be specified
(5)	Provides for an authorized person to carry out his functions
(6)	Provides for penalty for obstructing an authorized person without reasonable excuse

- (7) Sets out the functions which an authorized person may perform
- 9 Provides for review by the Administrative Appeals Tribunal of a decision regarding remission of penalty

10 Provides for regulations relating to collection, manner of payment, remissions or refunds, keeping of records, furnishing of returns, warrants and penalties.
