(HOWARD SPRINGS RECREATION RESERVE) BY-LAWS**

| Citation | 1. These By-laws may be cited as the National Parks and Gardens (Howard Springs Recreation Reserve) By-laws. |
| Definitions | 2. In these By-laws, "the Reserve" means the land that was committed to the care, control and management of the Board by notice in <i>Northern Territory Government Gazette</i> No. 47 of 1957 dated 20 November, 1957. |
| Admission times | 3. The Reserve is open to the public only from seven o'clock in the morning until eleven o'clock in the evening. |
| Admission fees | 4.—(1.) A fee is not payable for admission to the Reserve of a person who is under the age of seventeen years.

(2.) A fee of Ten cents is payable to the Board for admission to the Reserve of a person who is not under the age of seventeen years. |
| Fires | 5. A person shall not light a wood fire on the Reserve except in a fireplace provided by the Board.

Penalty: One hundred dollars. |
| Speed limit | 6. A person shall not drive a vehicle on an unsealed road on the Reserve at a speed in excess of 20 miles per hour.

Penalty: Fifty dollars. |
| Driving off roads and parking. | 7.—(1.) Subject to the next succeeding clause of this By-law, a person shall not drive a vehicle on the Reserve except on a road.

Penalty: Fifty dollars. |

(2.) A person may drive a short distance off a road for the purpose of parking.

8. A person shall not—

Boats

(a) place on or use on the waters of the Reserve a boat or canoe the length of which exceeds 10 feet; or

(b) propel a boat or canoe on the waters of the Reserve by means of an engine.

Penalty: Forty dollars.

9. A person shall not fish in the waters of the Reserve.

Fishing

Penalty: One hundred dollars.

10.—(1.) A person shall not permit a horse or bovine animal belonging to him or in his charge to enter or remain on the Reserve.

(2.) A person who permits a dog belonging to him or in his charge to enter or remain on the Reserve shall ensure that either it is not permitted to run free or else—

(a) it is securely held on a leash;

(b) it does not enter the water; and

(c) it does not enter a building.

Penalty: One hundred dollars.
