An Act to amend the Crown Lands Act, 1929, the Vermin Act, 1914, the Wild Dogs Act, 1912, and the Discharged Soldiers Settlement (Relief) Act, 1925.

[Assented to, November 20th, 1930.]

E it Enacted by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

1. (1) This Act may be cited as the "Crown Lands (Administra-Short title. tion) Act, 1930".

2. Part II. of the Crown Lands Act, 1929, is amended by insert- Amendment of ing therein after section 8 the following section:

1923, 1929, Part II .-

8a. (1) The Governor may appoint a Director of Lands and Director of Lands an Assistant Director of Lands.

and Assistant Director of Lands.

- (2) Every person appointed as aforesaid shall be appointed under and be subject to the provisions of the Public Service Act, 1916.
- 3. The Crown Lands Act, 1929, is amended in manner set forth Amendment of 1923, 1929. in the First Schedule to this Act.
- 4. The Vermin Act, 1914, is amended in manner set forth in the Amendment of Second Schedule to this Act.
- 5. The Wild Dogs Act, 1912, is amended in manner set forth in Amendment of 1102, 1912. the Third Schedule to this Act.
- 6. The Discharged Soldiers Settlement (Relief) Act, 1925, is Amendment of amended in manner set forth in the Fourth Schedule to this Act.
