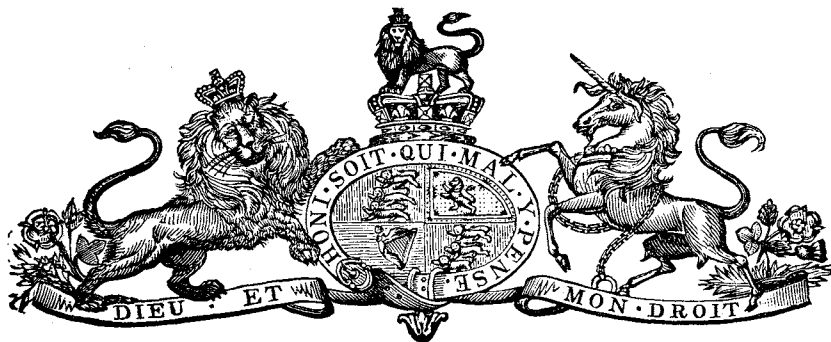

AN ACT to vest in the Trustees of the *Campbell Town Hospital* the Property known as "The *Campbell Town Grammar School*." [16 October, 1888.] A.D. 1888.

WHEREAS by an Indenture dated the Tenth day of *December* in the year One thousand eight hundred and sixty-two, and made between *Thomas Bolivar Blyth* of the first part, *John M'Leod*, *John Foster*, and *John Abbott* of the Second part, *William Valentine* of the Third part, and *George Patten Adams* of the Fourth part, the said parties thereto of the First and Second parts assigned and surrendered and also granted and confirmed the piece or parcel of land, messuage, and hereditaments described in the Schedule hereto to such uses as the said *William Valentine* should by any deed or deeds appoint : PREAMBLE.

And whereas by a subsequent Indenture dated the Eleventh day of *August* in the year One thousand eight hundred and sixty-three, and made between the said *William Valentine* of the one part and the Honourable *Robert Quayle Kermode*, the Reverend *Adam Turnbull*, *Thomas Mason*, *Charles Hill Harrison*, *James Gibson*, *Thomas Gibson*, and the said *William Valentine* of the other part, reciting that the said *William Valentine* had purchased the said piece or parcel of land, messuage, and hereditaments to the intent that the same should be used thenceforth as a School to be called "The *Campbell Town Grammar School*," under the Rules and Regulations and subject to the provisions therein contained, and that the said parties thereto of the Second part had been appointed and had consented to act as Trustees of the said School, and that it had been agreed that the said piece or parcel of land, messuage, and hereditaments should be

appointed and conveyed to them by the said *William Valentine*, the said piece or parcel of land, messuage, and hereditaments were conveyed and assured by the said *William Valentine* unto all the said parties thereto of the Second part, their heirs and assigns for ever ; and the said parties thereto of the Second part thereby declared that they and the survivors or survivor of them, and the heirs and assigns of such survivor, should stand seised and possessed of the said piece or parcel of land, messuage, and hereditaments for the use, benefit, and regulation of the said School :

And whereas the present Trustees of the said School are the said *Adam Turnbull*, *James Gibson*, and *Thomas Gibson*, but no School has been conducted on the said piece of land or elsewhere under the provisions of the said Indenture of the Eleventh day of *August*, One thousand eight hundred and sixty-three, for many years past, and it is the wish of the said *Adam Turnbull*, *James Gibson*, and *Thomas Gibson* that the said piece or parcel of land, messuage, and hereditaments should be vested in the Trustees of the *Campbell Town Hospital*, to be held and used by them and their successors for the same purposes as the said Hospital is held and used by them :

And whereas it is desirable that effect should be given by legislation to the said wish of the said *Adam Turnbull*, *James Gibson*, and *Thomas Gibson* :

Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

Land vested in Trustees *Campbell Town Hospital*.

**1** The piece or parcel of land described in the Schedule hereto is hereby vested in the Trustees for the time being of the *Campbell Town Hospital* and their successors, to be held and used by them for the same purposes for which the said Hospital is used by the said Trustees.

If Hospital registered, land to vest in Governing Body.

**2** If at any time the *Campbell Town Hospital* shall be registered under the provisions of "The Charitable Institutions Act, 1888," the piece of land described in the Schedule hereto shall thereupon become vested in the Governing Body of the said Hospital, without any deed of conveyance or other instrument of transfer or assurance from the Trustees of the said Hospital at the time of registration.

Indemnity to all persons.

**3** The said *Adam Turnbull*, *James Gibson*, and *Thomas Gibson*, and all other persons, are henceforth released and discharged from all duties, obligations, and trusts imposed upon them as Trustees of the said School by any deed or deeds heretofore executed by them or any of them.

## SCHEDULE.

---

All that piece or parcel of land containing by admeasurement two acres one rood and thirty-three perches, be the same more or less, situate and being in the Town of *Campbell Town*, in *Tasmania*, and bounded as follows, that is to say :—On the west by a southerly line extending from *Church-street* six chains and seventy-three links along an allotment claimed by *Hezekiah Harrison*, and along Crown land to the north boundary of an allotment granted to Mrs. *Abbott*, on the south by four chains and thirty links extending easterly along that grant to *High-street*, on the east and north-east sides by *High-street* to its angle with *Church-street* aforesaid, and thence by a westerly line along *Church-street* to the point of commencement.
