AN ACT to amend the *Burnie Sewerage (Parklands Estate) Act 1931*. [13 December, 1938.]

WHEREAS, by reason of the recent increase in house building on the Parklands Estate and lands adjoining thereto, it is expedient to improve and extend the drainage and sewerage system of the said Estate and to authorise the Warden, councillors and electors of the Municipality of Burnie to borrow the further sum of one thousand six hundred pounds:

Preamble.

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the

Short title.

1 This Act may be cited as the *Burnie Sewerage (Parklands Estate) Act 1938*.

2 The *Burnie Sewerage (Parklands Estate) Act 1931* is hereby amended as follows :—

- i. As to section two, by deleting the words “*Emu Bay*” at the end thereof and substituting the word “*Burnie*”:
- ii. As to section four, by deleting the words “six hundred pounds” in the sixth line thereof and substituting the words “two thousand two hundred pounds”, to the intent that the amount authorised to be borrowed should be increased by one thousand six hundred pounds :
- iii. As to the schedule by—
 - (a) Adding at the commencement thereof the word “*Firstly*”: and
 - (b) Adding at the end thereof the words “secondly the adjoining lands bounded as follows—starting from the south-west corner of *Parklands Estate* thence in a southerly direction for a distance of 364.8 links to the south-east corner of land now or formerly belonging to one *Louisa Mollison* thence in a westerly direction for a distance of 939.1 links along the southern boundary of the last mentioned land and the land known as *Mollison’s Estate* (being the lands comprised in subdivision plans filed in the Lands’ Titles Office, Hobart, No. 104/22) and of land now or formerly belonging to one *Alan Everard Hilder* comprised in certificate of title registered volume 404 folio 43 to the eastern boundary of land now or formerly belonging to one *Thomas Roy Hilder* known as *Hilder’s Estate* and being the lands now or formerly comprised in certificate of title registered

volume 404 folio 61 thence in a southerly direction along the said eastern boundary for 340·2 links to the south-eastern corner of Hilder's Estate thence in a westerly direction for a distance of 968½ links to the south-western corner of Hilder's Estate and to land now or formerly belonging to one *George Bennett* thence on the west in a northerly direction along the western boundary of Hilder's Estate for 861 links or thereabouts to the Main Coast Road thence by the southern side of the said Main Coast Road in a general easterly direction to the north-west corner of Parklands Estate thence in a southerly direction via the western boundary of Parklands Estate to the point of commencement " A.D. 1938.
