AN ACT to amend "The Fertilisers Act, 1912," and for other purposes. [24 December, 1919.]

A.D. 1919.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

1 This Act may be cited as "The Fertilisers Amendment Act, Short title and 1919," and shall be construed and read as one with "The Fertilisers incorporation with Act. 1912" in this Act referred to as the Principal Act. Act, 1912" in this Act referred to as the Principal Act.

Amendment of Section 3 of Principal Act.

2 Section Three of the Principal Act is hereby amended—

1. As to the definition "Director," by inserting at the end of the definition the words "and includes an Acting-Director of Agriculture":

11. As to the definition "fertiliser," by omitting therefrom the words "in appreciable quantity":

11. By omitting the definition "sell," and substituting therefor the following:

> The verb "to sell," in whatever person, number, tense, mood, or voice it is used, includes-

1. To barter or exchange:

II. To agree to sell, barter, or exchange:

III. To offer, expose, store, have in possession, send, consign, or deliver for or on sale:

iv. To receive for sale:

v. To cause or suffer to be sold, bartered, or exchanged, or to be agreed to be sold, bartered, or exchanged:

vi. To cause or suffer to be offered, exposed, stored, had in possession, sent, consigned, or delivered for or on sale:

vii. To cause or suffer to be received for sale: and viii. To attempt or assist to do any of such acts or things--

and all participles of the verb "to sell" and the noun

"sale" have corresponding connotations;

The verb "to buy," in whatever person, number, tense, mood, or voice it is used, includes to receive or accept under a sale or agreement to sell, and to offer to receive or accept or cause or suffer to be received or accepted under a sale or agreement to sell; and all participles of the verb "to buy" have corresponding connotations.

3 After Section Six of the Principal Act the following section is inserted:-

"6a-(1) The chemist of the Department of Agriculture—

1. From the result of the analyses of fertilisers set forth in the certificates delivered annually to the Director pursuant to Section Six of this Act, and taking into account the constituents which have a commercial value, and the value thereof in the simple fertilisers in which they occur, shall calculate the average unit values of such constituents; and

II. Shall then compile a complete list of all the fertilisers in respect of which such certificates have been so delivered, showing-

(a) The prices asked for the same;

(b) The average unit values as so calculated;

(c) The several distinctive names or brands of such fertilisers; and

(d) Such other matters as may be prescribed.

Fertilisers Amendment.

(2) Such list may be referred to as the "annual list of fertilisers," A.D. 1919. and shall be published in at least One newspaper circulating in this State as soon as practicable after the First day of March in every

- (3) The average unit values from time to time set forth in any such list shall constitute the basis for calculating the values of all fertilisers for the period indicated for the purpose in such list.
- 4 Subsection (1) of Section Eight of the Principal Act is hereby Amendment of amended as follows:—

Section 8 of Principal Act.

1. As to Paragraph IV., by inserting the word "only" immediately after the word "stating," occurring in the First line of the paragraph:

II. By inserting at the end of the subsection the following

paragraph:-

"v. Such particulars as may be prescribed respecting the monetary value of the ingredients nitrogen, phosphoric acid, and potash, contained in the package, calculated upon the basis of the unit values ascertained and from time to time declared by the chemist of the Department of Agriculture; and such other particulars as may be prescribed.

5 Section Twelve of the Principal Act is hereby amended—

Amendment of Principal Act.

I. As to Subsection (4) thereof, by omitting therefrom the words Section 12 of "in the 'Agricultural Gazette'" and substituting therefor the words "for public or general information in or by any newspaper circulating in any part of this State, and the publication thereof in any newspaper shall not render the proprietor, printer, or publisher thereof liable to any action or proceeding in any court whatsoever."

11. As to Subsection (5) thereof, by omitting therefrom the words "Prior to the publication thereof in the 'Agricultural Gazette."

6 Section Twenty-five of the Principal Act is hereby amended by Amendment of inserting the following paragraphs immediately after Paragraph III. Section 25 of thereof:-

"IIIA. Regulating and fixing standards for fertilisers:

"nib. Prescribing the size, form, and quality of the printed labels required to be affixed to packages of fertiliser, the information to be set forth thereon, and the manner of printing thereof."
