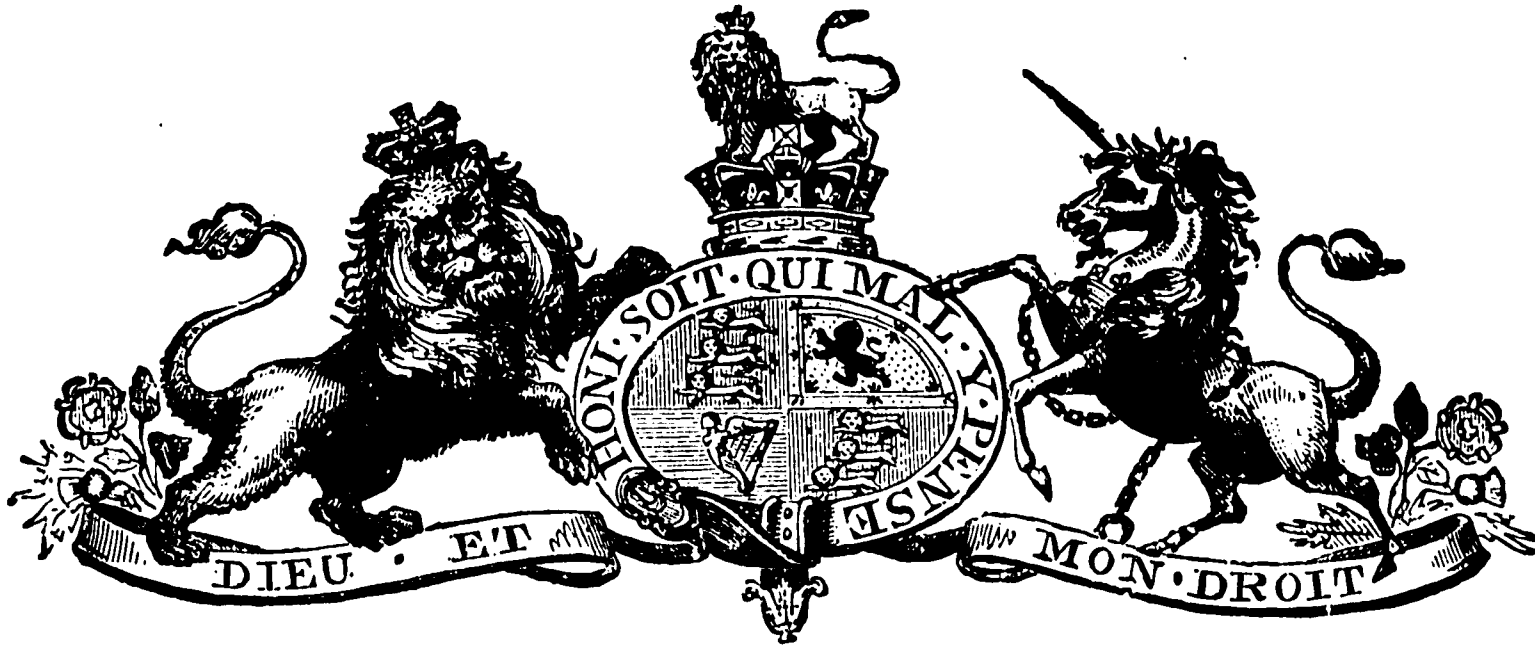

An Act to correct certain errors in Acts.

[23rd December, 1891.]

WHEREAS errors have been discovered in certain Acts of Parliament and it is expedient that the same should be corrected: Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say) :—

1. This Act may be cited as the *Statute Law Revision Act* 1891. Short title.

2. The Acts mentioned in the Schedule to this Act to the extent to which the same are in and by the said Schedule expressed to be amended are hereby amended accordingly, and the said Acts shall be read and construed accordingly. Amendments to be made in Acts. Schedule. No. 1176 §. 2.

3. Every copy of any of the said Acts printed after the commencement of this Act by the Government Printer for Victoria shall be printed with the additions omissions insertions and substitutions required by this Act. Printing of amendments. See ib. s. 3.
