An Act to revise the Statute Law and for other purposes.

[31st December, 1930.]

BE it enacted by the King's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):—

Short title.

1. (1) This Act may be cited as the Statute Law Revision Act 1930.

Commencement of Act.

(2) Save as otherwise expressly provided in this Act, this Act shall be deemed and taken to have come into operation on the eighteenth day of December One thousand nine hundred and twenty-nine.

Amendments to be made in Acts. Schedule. 2. The Acts mentioned in the Schedule to this Act to the extent to which the same are in and by the said Schedule expressed to be amended are hereby amended accordingly and the said Acts shall be read and construed accordingly.

References in this Act to sections, &c., amended by other Acts. 3. Wherever in this Act a section or other provision of any Act is referred to and such section or other provision has been amended by any Act other than this Act such reference shall be construed as relating to such section or other provision as so amended.

Issuing by Government Printer of Acts mentioned in Schedule. 4. Every copy of any of the Acts amended by this Act issued after the commencement of this Act by the Government Printer of Victoria may be issued with the alterations additions omissions insertions and substitutions provided for by this Act.
