An Act to revise the Statute Law.

[5th May, 1964.]

BE it enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):—

Short title.

1. This Act may be cited as the *Statute Law Revision Act 1964*.Amendments

2. The amendments made in the Schedule to this Act to the extent to which the same are in and by the said Schedule expressed to be repealed or amended are hereby repealed or amended accordingly and the said Act shall be read and construed accordingly.

In paragraph (d) of sub-section (1) of section eighty for the expression "sub-section (5) of section thirty-eight" there shall be substituted the expression "sub-section (7) of section thirty-eight".
