Statute Law Revision Act 1981

No. 9549

An Act to revise the Statute Law.

[Assented to 19 May 1981]

BE IT ENACTED by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):

1. (1) This Act may be cited as the *Statute Law Revision Act* Short title. 1981.

(2) Subject to section 2 (2), this Act shall come into operation Commence- on the day on which it receives the Royal Assent. ment.

2. (1) The Acts mentioned in the Schedule to the extent to Schedule. which they are in that Schedule expressed to be amended or repealed shall be amended or repealed accordingly.

(2) This Act shall be deemed to have come into operation with respect to the amendments made by the following items in the Schedule on the following dates:
