## Statute Law Revision Act 1983

No. 9902

An Act to revise the Statute Law of Victoria.

[Assented to 15 June 1983]

BE IT ENACTED by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):

Short Title.

1. (1) This Act may be cited as the *Statute Law Revision Act 1983*.

Commencement.

(2) Subject to section 2 (2), this Act shall come into operation on the day on which it receives the Royal Assent.

Schedule

2. (1) The Acts mentioned in the Schedule to the extent to which they are in that Schedule expressed to be amended or repealed shall be amended or repealed accordingly.
