Statute Law Revision Act 1995

[Assented to 26 April 1995]

The Parliament of Victoria enacts as follows:

1. Purpose

The purpose of this Act is to repeal Acts and provisions of Acts which no longer have any purpose or effect.

2. Commencement

This Act comes into operation on the day on which it receives the Royal Assent.

3. Repeals

- (1) The Acts listed in Schedule 1 are **repealed**.
- (2) The provisions listed in the third column of Schedule 2 are **repealed**.
